

### **Charlotte Regional League, Event #1, PM Wave, 12's Division**

The 12's division will begin at 2:30 pm. The 12's competition will take place in two waves. In the first wave, teams will compete in three team pools, followed by a Gold Bracket and a Consolation match between 3<sup>rd</sup> place teams. Bracket and Consolation matches will begin around 6:00 (possibly earlier) after teams have a brief break to grab a snack. All matches will be preceded by a 2-4-4 format (2 minutes shared warm-up, followed by 4 minutes of individual team court time).

#### **Wave 1**

Teams will be split up into three pools. The three team pools will play round robin to determine 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup>. NO TIE BREAKING SETS WILL BE PLAYED. All three-way ties within three team pools will be broken in the following order: Set Win-Loss Record, +/- of points won and lost, coin flip.

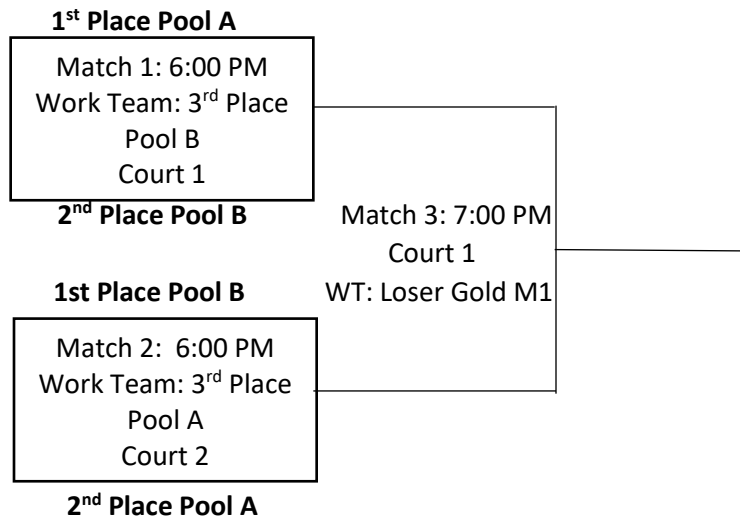
