



TEAM Acceptance Instructions:

If you have been invited to and have accepted a spot on one of the 2018 Travel teams – then please complete your team registration asap.


1. Click on the Link we send OR: Log into your dashboard: <http://www.carolinaucv.com/parent-login/> and click on Club Teams:



2. Scroll to your Team's location and click on View Details:




3. Scroll to your team and click on Register:

*If you want to pay at the meeting – you **MUST** select the middle option – not the 3rd option! 3rd option is to complete payment immediately.*

Please also note – those totals include the processing fee – if you are paying by check – reduce the amount by the listed processing fee.

C. Click on the Payment Plan of your choice – THIS IS REQUIRED and not Changeable once you select your plan - so please **do not select the pay upfront option and then only bring the deposit to the Meeting or vice versa.**

Payment Options are:

- Installments – Required Credit Card stored on file. Select this option and then complete the CC info and either complete Deposit payment online **OR Skip and Pay Later** to pay with Cash or check at the Parent Meeting.
- Pay in full at the parent meeting for a 3% discount and no processing fee. Cash or Check only – No credit cards at the meeting. Select this option then go to **Skip and Pay later on** the payment page – **WE WILL ADJUST THE INVOICE AFTER PAYMENT IS RECEIVED – so be sure to fill your check out correctly or wait until the meeting.**
- Pay in full online with Credit Card and Processing Fee – select the **Pay All Dues Now** Option and complete payment on the next page.
